Treasurer's Report 2019/20

This is my second report as your Treasurer and the first full accounting year in the role. Since March 2020 Coronavirus has affected all our lives in many ways and this has included the management of the Seniors Section finances. This has involved moving from using cash to online banking for competition entry fees. I am grateful to all members for their support in implementing this required change.

The accounts prepared for this fiscal year continue to replicate a format that has been used for many years and easily afford comparisons to be made on both income and expenditure.

In terms of income in 2019/20 it is pleasing to see both subscription numbers and competition entry fees have increased, the latter substantially. Entries in all qualifying competitions, knockouts and Winter League were higher in 2019/20 than 2018/19 and this has been a major contributor to the surplus shown in the accounts.

The Captain has decided that amounts raised from "Frog" contributions in 2019/20 will be held over and added together with further monies raised in 2020/21 for one donation to charity at the end of that year.

Expenditure in 2019/20 has largely replicated 2018/19. The donation to LGC relates to a commitment made in 2018/19 and the tee sponsorship payment was for the final year of a three-year arrangement. Your Committee will look to discuss a new tee sponsorship deal with LGC and work with the Club to look at initiatives requiring financial support.

It was intended to hold a Vice Captain's Away Day in 2020 and the deposit was paid. Due to Covid-19 the event had to be postponed and has now been rearranged for 2021.

Proposals regarding the Annual Subscription fee, competition entry fees, bereavement donations & all annual payments are shown at Appendix 1.

Given that the balance sheet shows a surplus of £907 it is proposed that prize money is increased for all competitions in 2020/21. The proposed increases are detailed at Appendix 1.

Finally, my thanks go to my fellow Committee members for an excellent working relationship this year and to all Seniors for their support.
