# Minutes of the 46<sup>th</sup> Annual General Meeting of the Lincoln Golf Club Seniors held on Wednesday 19<sup>th</sup> November 2025 in the Clubhouse

Out of a membership of 106, 31 members attended the meeting. Apologies were received from Dinesh Shah, Nigel Harrison, John Edlington, John Kidney and John Shaw.

The meeting began at 1330 hours

#### **Minutes of the Annual General Meeting 2024**

The minutes of the 45<sup>th</sup> AGM held on Wednesday 20<sup>th</sup> November 2024 were adopted following a proposal by John Shaw, seconded by Phil Pearson. The membership agreed that the Minutes reflected a true record of the meeting.

#### **Treasurer's Report**

This is my seventh Annual report as your Treasurer and the sixth full accounting year in the role. The accounts prepared for this fiscal year continue to replicate a format that has been used for many years and affords comparisons to be made on both income and expenditure.

The substantial difference between income and expenditure in 2024/25 and income and expenditure in 2023/24 is due to the financial management of the away days being handled by the organiser in 2024/25.

In terms of income in 2024/25 subscription and competitions income were strong but down on 2023/24. Subscriptions paid were down from 119 to 107 due in part to less new members joining than in previous years. Competition income was down by £215 due to less people taking part in the Winter League, the poor winter conditions reducing Laverack trophy entry fees and less people entering the summer knockouts. Income was at a similar level in 2025 for the Summer QCs as in 2024.

Income from two Seniors Sixes competitions plus tight monitoring of "Frog" contributors resulted in a bumper Captain's Charity collection.

Regarding expenditure, the Committee continued to recognise the excellent work of the Greens staff by a gratuity. Prizes paid out were 84% of entry fees, well in line with the financial strategy. We continued to support LGC by sponsoring the 12<sup>th</sup> tee.

Even with a reduced income from subscriptions and competition fees a small surplus has been achieved. This is due to no bereavement payments being paid, and this year no financially supported project with LGC. We hold a healthy surplus at the moment but need to keep a watchful eye on income streams.

It is recommended for 2025/26 that the Annual Subscription, competition entry fees, bereavement donations and all annual payments are unchanged.

Finally, my thanks go to my fellow Committee members for an excellent working relationship this year and to all Seniors for their great support in what has been an extremely busy year for me.

# Paul Stafford Treasurer LGC Seniors Section

Paul proposed that we accept his balance sheet as a true record. This was seconded by Nick Todd and carried by a show of hands

#### Proposals to be considered

- 1. That the annual subscription of £5 and competition entry fees remain unchanged.
- 2. That all annual payments (greenkeepers gratuity £250, secretary's honorarium £50) and the bereavement donation of £50, remain unchanged.

#### **Secretary's Report**

Most of the season ran on rails. I believe we have an efficient and robust system for running our matches and competitions. Such events only require minor tweaking to reflect the events of the day.

One of the highlights of the year was the invitation from Luffenham Heath to play matches against them in alternate years. We played them at their course in the Spring and, although we lost narrowly (4 ½ to 3 ½), most of the matches were close-fought affairs. We look forward to hosting Luffenham Heath at Torksey on Friday 17<sup>th</sup> July 2026.

The two other major items which took my attention this year were replacing Newark and Sleaford with Worksop and Stanton on the Wolds respectively. Before going public with these decisions, we had to do much work in the background to prepare the ground. The initial stumbling block with Stanton was our early start time. Our Manager, Louis, kindly allowed us to trial a lunchtime start with the fixture against Waltham Windmill. It proved a qualified success but, in reality, we started slightly too late. We will be aiming for a lunchtime start against Stanton but will refine the schedule we followed this year. More to follow in due course.

It was sad to have to remove Newark and Sleaford from our roster after so many years but those members who played at these venues this year will understand the reason for our decision. It was pleasing to note that both clubs accepted our decision with good grace.

The meeting gave a vote of thanks for all the excellent work that John May had done for the Section in 2025 and wished him a speedy recovery from his eye surgery.

#### **Seniors' Captain's Report**

Its been my privilege to be seniors Captain for 2025. My year has flown by. This year we had some great results in the Tulip Trophy which resulted in winning 5 and losing 1. I've been able to use 46 Seniors over the 26 matches with 16 wins 2 draws and 8 losses. We are looking forward to next year with 2 new venues of Worksop and Stanton on the Wolds and finally i would say big thankyou to Simon for doing the coffee at home matches and wishing him all the best next year as he replaces me as Captain for 2026.
